BC Summer Swimming Association Notes to the Financial Statements

Year Ended March 31st. 2017

1. General Information

The B.C. Summer Swimming Association (the "Association") is incorporated under the Society Act of British Columbia. The Association is a provincial organization operating and regulating summer aquatic sports in British Columbia. The primary objective of the Association is to promote the development of its athletes through participation in competitive aquatic sports and to provide opportunities for training, competition and related activities in communities throughout British Columbia and surrounding areas.

The Association does not consolidate the financial results of the participating regions as these entities are not considered to be subsidiaries of the Association and the Association does not have direct financial control over these regions.

The Association is a not-for-profit organization registered under the Income Tax Act and, as such, is exempt from income tax.

2. Significant Accounting Policies

Basis of Presentation

These financial statements have been prepared by management in accordance with Accounting Standards for Not-for-Profit Organizations ("ASNPO"). These financial statements reflect the combined assets, liabilities, net assets, revenue and expenses of the Association's provincial office and its operations.

Revenue Recognition

The Association follows the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year when the related expenses are incurred. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

Donated Services & Supplies

The Association benefits from the donated services of time from volunteers for the various activities conducted on its behalf and donated supplies from various sources. These donated services and supplies are not recognized in the financial statements.

Inventory

Supplies (rulebooks & officials pins etc.) purchased are capitalized as inventory using the weighted average cost method. As of March 31, 2017, \$Nil (2016 - \$1,076) of these supplies have been capitalized on the balance sheet as the net realizable value of the



inventory has been determined to be \$Nil as inventory is provided to members free of charge.

Use of Estimates

ASNPO requires the Association to make estimates and assumptions about future events that affect these financial statements. The Association believes that the estimates used are reasonable; however actual results could differ from those estimates. Significant areas requiring the use of estimates relate to the determination of the useful lives of assets for amortization, provisions for uncollectible accounts receivables, and the amounts recorded as accrued payroll liabilities.

Capital Assets

Capital assets are recorded at cost. They are depreciated on a straight-line or declining balance basis over their estimated useful life at the following rates:

Capital assets exceeding \$1,000 are capitalized. Deprecation is taken in the year of acquisition using the half year rule.

4. Vancouver Foundation Endowment Funds

The Vancouver Foundation holds two endowment funds, the capital of which is not represented on these financial statements. Income from the endowment funds is disbursed at the discretion of the Vancouver Foundation upon the recommendations made by the Association and is designated, on an annual basis, to the Association's scholarships. The fund was established on March 29, 2017 with an initial capital contribution of \$200,000. The fair value as of March 31, 2017 is \$200,000 (2016 - \$Nil).



5. Provincial Championships

This data relates to the 2016 Provincial Championships held in Coquitlam, BC, on August 15 to 21, 2016. The financial results of the Championships are included in these financial statements.

6. Grants & Club Reimbursements

The Association granted funds and reimbursed certain expenses of member clubs and regions as approved by the Board of Directors. This data relates to any grants or reimbursements paid in the fiscal year.

Capital Funding Grant Program

Grants were paid to both clubs and regions for capital expenditures. Clubs and regions were required to apply for funds through an application and review process. Data below is broken out regionally, but some member club received grants directly.

Club Reimbursement – Hy-Tek Sports Software

The Association continued with reimbursing clubs and regions for the upgrade cost of the Hy-Tek Sports Software program as required. For the year ended March 31, 2017, the total reimbursement was \$Nil (2016 - \$12,996).

Club Reimbursement – Officials Name Tags/Rulebooks

The Association reimbursed clubs and regions through a direct rebate to cover the cost of name badges, rulebooks and pins. For the year ended March 31, 2017, the total cost absorbed by the Association was 14,624 (2016 – 44,568).

Financial Aid – Club Membership Fee Assistance


The Association provided financial assistance directly to clubs who applied on behalf of athlete families who were not able to afford the full amount of clubs fees for the 2016 summer swim season. Financial assistance was no more than 50% of the total fee charged by the member club. For the year ended March 31, 2017 the total assistance provided was \$3,819 (2016 - \$3,065)

A statement of cash flows has not been prepared as the statement would not provide additional useful information.




Financial Overview

President's Report

Season number 59 is almost finished and we will be starting on our 60th year of the BCSSA, our Diamond Jubilee. My wife, Kerry, is thinking that a diamond should be in the works but I pointed out to her that she has only been around the organization for a short 42 years, not enough for a Diamond yet.

I have been very pleased at how your Provincial Board has been quietly working on several different initiatives on your behalf. After several years of research we have now set up an Endowment Fund with the Vancouver Foundation. This endowment fund is available for anyone to make a charitable donation to but most importantly the fund will be supporting our Regional Scholarships that we hand out. Each year a \$1,000 award goes to one coach or senior swimmer in each region to help pay for post-secondary education. This award is now secure for generations to come and has the ability to grow through donations and accumulated interest so that in the future even more of our swimmers can benefit. If you or a company you know is interested in contributing, please check out our web site or contact the office.

The Coaches Conference was back at RockRidge Canyon for the third year and once again we had high levels of participation and high quality presentations. This conference gets better and better each year and I would urge all clubs to do everything they can to get their coaches to the conference. We will continue to try and have the main presentations done by our own coaches.

Speaking of coach training as well as official and club officials training, the Board announced a new fund, the Strategic Plan Implementation Fund. This fund was put in place to help complete our Strategic Plan. Clubs and regions can apply for funds to help initiate their parts of the Provincial Strategic plan, especially when the plan involves training of coaches, officials and club board members.

As in the past, the Capital Grant Program is alive and well as is our own Registration Assistance Fund. Clubs continue to apply and draw from those funds to help pay for capital purchases such as lane ropes, computers and starting blocks as well as supporting swimmers that may not be able to afford our program.

I believe it is time to examine the requirements and participation levels of our four aquatic sports at the Championship meet (speed swimming, diving, water polo, synchronized swimming). Right now we have a one size fits all as far as requirements for qualifying to Provincials and participation at the Championship meet goes. Yet each sport is unique in the number of participants, the requirements for having a competition and the resources available. A 60th anniversary is a good time to re-examine our meet and our season and I look forward to reporting back to you, the membership, after the discussions take place.

In summary, our organization is doing well. There are always issues to deal with but as in the past, I am confident our membership will work together. Good luck to all athletes at our 59th annual meet and good luck to all teams, I hope you have a banner year for membership in 2018.

Vice-President's Report

In the 2016 Vice-President's Report, I reported that the BCSSA Board endorsed the BCSSA 2016-2020 Strategic Plan ("Plan"). The Plan guides all planning processes for the association as a whole based on three fundamental elements: our vision, our mission and our core values.

Our Vision

To be a leading sport organization, fostering a culture of inclusiveness, fun, and achievement.

Our Mission

The BC Summer Swimming Association (BCSSA) promotes, and encourages the development of athletes and volunteers through participation in speed swimming, diving, water polo and synchronized swimming.

Our Core Values

Through its member clubs, BCSSA provides opportunities for training, competition and activities in communities throughout BC and surrounding areas.

BCSSA promotes the development of an individual's capacity to achieve excellence and life skills through participation in competitive aquatic activities.

The Plan is a living document that will guide BCSSA over the term of the Plan. It is a mechanism to proactively address opportunities and challenges as they arise in order to achieve our vision, mission and core values. The Plan will continue to evolve as tactics are achieved and the needs of the association change.

The Plan outlines fifteen initiatives in four strategic priorities, which are Organizational Development, Community Building, Achievement and Partnerships, that frame and drive our annual budget and work plans. I am pleased to report that many of the tactics identified in the Plan have either been completed, are in-progress or under development. Some of the highlights include:

- Upgraded visual, audio and computer equipment to make BCSSA's office a centre for training officials, coaches, Board, etc. (e.g. live video presentation).
- Developed a portal for Board members to communicate and share information more effectively.
- Negotiated and executed an Agreement between BCSSA and Active Networks to expand online registration and payment options.
- Created the BCSSA Endowment Fund and the BCSSA Transferable Fund in partnership with the Vancouver Foundation which provide stable funding to the BCSSA for our long term goals and a sustainable revenue source for the Regional Prizes.
- Completed a social media policy.
- Updated the consent and waiver form.
- Financially supported 10 Volunteer Coaches Clinics across seven BCSSA regions.
- Financially supported coaches in all regions to attend the Coaches Conference at RockRidge Canyon.



• Created the Strategic Plan Implementation Fund to support the initiatives and tactics of the Strategic Plan.

Our Strategic Plan is a living roadmap that will guide the association and will help us to prioritize and balance all of the issues facing us. Ultimately, we must continue to improve and challenge ourselves to maintain our reputation "To be a leading sport organization, fostering a culture of inclusiveness, fun, and achievement."

Thank you to those who have assisted me in serving in my role as the Vice-President this year. I look forward to seeing you at the Provincial Championships in Kamloops.

Secretary Treasurer's Report

On behalf of the Finance Committee, I am pleased to report that BCSSA remains financially stable and in a position to support our programs and strategic initiatives, providing opportunities for training, development and competition within British Columbia.

We continue to ensure prudent financial management practices are in place and continue to monitor our internal control processes, allowing us to manage our financial resources appropriately and provide direct financial benefits to our regions and clubs.

As in prior years, the Board has continued to focus its efforts to provide financial assistance programs to BCSSA member clubs and regions. During the 2017 fiscal year, the BCSSA distributed funds and/or covered expenses in the following categories:

•	Capital funding grants	\$ 26,888
•	Officiating supplies distributed	\$ 14,624
•	Financial aid	\$ 3,819

There have been no significant changes to BCSSA's operations or controls. As in prior years, a financial peer review was once again conducted this past June. This review has specific procedures conducted over revenues, expenses and balance sheet line items. I would like to thank Jennifer Ng for volunteering her time to perform this peer review. All recommendations have been taken into consideration and any financial adjustments were made accordingly.

The following is a summary of the fiscal year's financial results:

- Registration income increased by 7.9%. This is directly tied to a slight increase in overall registration in summer and winter membership categories, as well as the approved registration fee increase which was effective May 1, 2016.
- The 2016 Coaches Conference was held at RockRidge Canyon, in Princeton, BC. This event generated approx. \$24,950 in revenue with total expenses of \$37,302. The event was successful in the prior year (May 2015) and therefore a larger scale event was planned during the 2016 season. BCSSA budgeted to absorb the loss of approximately \$12,000 and therefore was able to keep participant fees low as a benefit to our member clubs who normally pay for coaches to attend the annual conference.
- The staging of the 2016 Provincial Championships saw a surplus of \$10,906. We would like to thank the Coquitlam Sharks and the Simon Fraser Region for their attention to controlling costs and obtaining increased sponsorship for this annual event. Without sponsorship and equipment loans, BCSSA would not be able to host such a high caliber event on a break even or surplus basis. This event on occasion will experience a financial loss as some host locations are more expensive, however BCSSA wishes for the Provincials to take place throughout the province and therefore budgets accordingly. As a thank-you to the local organizing committee, the BCSSA provided a hosting grant to the Coquitlam Sharks for securing significant sponsorship for the 2016 event.

- Program operations saw an overall expense increase of 8.7%. This increase is attributable to the coaches' conference and provincials, which were larger scale events in the year resulting in increased costs.
- Administrative expenses increased 13.1% compared to the prior year. This increase is
 primarily the result of increased provincial office expenses and salaries. BCSSA hired a coop student last summer to assist with office operations during the summer season. Having
 this student work with Disa in the office during the 2016 season proved to be very
 beneficial. The Board once again hired an Office Administrator for the 2017 season and we
 will be evaluating this position going forward.

During the January 2017 board meeting, BCSSA approved the establishment of the BCSSA Endowment Fund with the Vancouver Foundation. An initial contribution of \$200,000 has been made to the Vancouver Foundation by the BCSSA. The endowment funds are expected to generate sufficient income to support our scholarship program for our members moving forward. As the fund continues to grow, the BCSSA hopes to be able to offer more scholarships.

Subsequent to year end the Board approved the Strategic Plan Implementation Program which provides regions and clubs with funding to carry out initiatives that align with the BCSSA Strategic Plan. Director of Competition's Report

The first is that the meet will be a huge success; largely due to the combined efforts of the Board, the facility, the city, and hundreds of club volunteers. The second is that the swimmers will amaze us with their performances, as they always do at this event. Quite honestly, that's what makes this whole thing worthwhile.

Director of Member Services Report

There's little point in inserting the ubiquitous *tempus fugit* type comment found in end-of-year reports except to point out that I stepped into Membership Services half-way through the two-year term. That said, I've wasted no time in assessing the needs and the opportunities that the Association can use to more energetically engage its membership.

Assessment of Membership Services: The approaching 60th anniversary of BCSSA is a natural focal point for the Association to galvanise its place in BC sport and showcase the significant contributions that Summer Swimming makes to the physical, personal and social development of young athletes in communities throughout our province. The BCSSA brand is strong (anecdotally but a more formal survey should be undertaken) but many of its assets (website, signage, marketing materials) require not just updating but strategic development and integration into a long-term plan that includes communications, public relations, government relations and inter-sport relations to place summer swimming on the top rung of aquatic sport in BC. The coming two years, with our 2018 Provincial Championship meet right in the middle, are a key opportunity for our Association to accomplish important goals related to the prominence of the BCSSA brand and the proper place summer swimming should occupy in BC sport.

General Updates: I've begun laying a foundation for an expanded presence in BC for summer swimming in general and BCSSA in particular. The first step was taken in March at the local club level by publishing a basic club marketing guide in the Spring 2017 edition of Wavelength. It is a compilation of the best marketing hacks (online and offline) learned through trial and error in promoting my home club, WRASA. Many local clubs are implementing all or parts of this plan. I also published a package guide to Active's Swim Manager that provides club executives with an overview of the online registration process and steps to migrating to Active online registration. Supporting the BCSSA Strategic Plan, the package includes a video introduction, a club communications template and a registrar's guide to processing online registrations. Many member clubs have now begun or completed an integration of Swim Manager into their registration process.

Director of Diving's Report

Program: In 2017 we had five clubs, representing three regions, with diving programs. An increase of two clubs since 2016:

- Coquitlam Sharks (SF Region) 9 divers (24 in 2016)
- Burnaby Barracudas (SF Region) 6 divers (15 in 2016)
- Port Moody Aquarians (SF Region) 25 divers, 10 attending regularly (new program)
- North Vancouver Cruisers (Vancouver & District) 45 divers, 24 attending regularly (50 in 2016)
- Abbotsford Whalers (Fraser Valley Region) 18 divers, 9 attending regularly (new program)

Fees and Practices: Three clubs (Cruisers, Burnaby and Port Moody) offered diving at no additional registration fee. Coquitlam charged \$150 for the second sport, and Abbotsford charged \$100 for the second sport. Practice frequency ranged from one to four practices per week.

Coaches: Several clubs had challenges securing coaches this year. I will continue to work with BC Diving to provide Dive Coach Training programs and to source qualified coaches for clubs who are interested in starting dive programs. Swimming coaches who are interested could take the two day Intro to Dive Coaching Clinic offered by BC Diving.

Officials: Many parents participated as shadow judges at club meets, with the goal to work towards having more parent judges, allowing the coaches to focus on coaching during meets. We will continue to work towards training more parent judges.

Clubs/Equipment: North Vancouver Cruisers and Burnaby had difficulty securing coaches this year. Burnaby was not able to start their dive program until late June because of this. Burnaby Barracudas were invited to practice with Port Moody Aquarians to train on the 3m board. Abbotsford Whalers have had great difficulty securing pool time (only available very early or very late).

Meets: There were only three club meets held in the 2017 season, two hosted by the Coquitlam Sharks. This was primarily due to new clubs having difficulty arranging pool time.

Rules: Diving requirements were reviewed last year, and modified to reduce the difficulty for new divers, and to split the groups between Summer Divers and Open Divers. This has increased overall participation at meets, however there are relatively few divers competing in the Open categories, leading to limited competition.

Summary: Two clubs added dive programs in 2017, which helped increase overall registration numbers from 89 to 103. Participation rates at meets increased for new divers, however there was little competition in the Open Categories. Two clubs had difficulty securing coaches. Focus for 2018:

- Work with BC Diving to train more coaches.
- Review the diving requirements to see if it is possible to increase competition in the Open Categories.

Director of Water Polo's Report

BCSSA water polo has enjoyed a promising year in some respects, with regards to growth in number of clubs and regions competing. Our programs continue to introduce a great number of athletes to the sport, while providing a starting point for many of our most successful water polo players now.

Other areas of the program have been highlighted as in need of re-examination. We have once again been confronted with a decline in participation in the U18 category – which saw a considerable bump in number of teams in 2016, before dropping down to three eligible teams for provincials this season.

Over the past two seasons, I have ruled on two appeals regarding players who were ineligible for BCSSA water polo due to participation at the U19 NCL national championships. In both cases, the athletes were deemed ineligible to compete, despite limited participation in actual gameplay. These situations, coupled with the chronically-weak U18 category suggests to me that the BCSSA eligibility rules are once again due for a discussion.

There has also been interest in establishing concrete rules for the wildcard selection process ahead of provincials. These are all discussions I welcome and look forward to having after the summer season has concluded.

New water polo programs were established this year, at the Nanaimo White Rapids Swim Club, as well as in Merritt. There have also been inquiries from the Kootenay region this season, with regards to running a regional water polo camp in the future. These camp-style events could serve to introduce the sport to more regions, as well as a way for more young water polo athletes to gain employment and experience in coaching. This is certainly an idea I'd like to pursue in the coming seasons.

I'd like to make a special mention of a number of former BCSSA water polo athletes, who represented Team Canada in water polo at the FINA World Aquatic Championships this summer. Congratulations to: Monika Eggens and Matthew Halajian, both former Haney Neptunes; Gaelan Patterson, a North Van Cruisers alumnus; Gurpreet Sohi (alternate) and Hayley McKelvey of the North Delta Sunfish; Reuel D'Souza and Sean Spooner (alternate) from the Coquitlam Sharks.

That's all for this season!

As this is my first year as Coaches Representative, I would like to acknowledge the spectacular amount of work that is put in each year by the Board of Directors each year, and thank you all for the extra time put in, especially this year in regards to keeping our swimmers safe and in venues unaffected by the fires this challenging season.

Okanagan Regional Director's Report

This was my first year as Regional Director, and it was a challenging year. We had numerous people who had contributed to our region for years, change at the board level. I welcomed a new Treasurer, Director of Competition and numerous new Presidents' from our regional clubs. Our region incorporated the Active Network system into each one of our clubs. This was not without many complications. Although, the system had boasted to allow us to have online club registration, it was unable to generate a BCSSA number. Swim Manager is unable to use divisions, S/O categories, and the BCSSA number. Although club registration is important, many of our clubs used Team Unify for many other purposes. Most of these needs, which are available in Swim Manager, at this time, will not work in Canada with our BCSSA divisions. Having said that, Active was very helpful in providing me temporary solutions such as a meet template that we could use for online meet registration. This option allowed coaches to create meet files in Swim Manager, saving a lot of time. Although, we are not using all of the options that will be available, the process is started and I can see the benefits of this change. I believe, that as Active is able to make the necessary changes for the BCSSA, it will only become easier.

As clubs withdrew from Team Unify, they lost their existing web presence. Active provided us with new web pages (at a very reasonable cost), that when finished will be fully integrated into Swim Manager. Over-all, a difficult transition, lots of learning and changing, but again our process has started. I believe it will get much easier next year, and will hopefully save hours of administration for all of our club boards.

Our first meet was cancelled in Revelstoke due to the closure of Highway 1. This was the first time in over 20 years that a meet had been cancelled in our region. It was difficult but the local club was able to rebook the meet in the only available weekend left in the summer schedule. Due to the fires and potential air issues in Kamloops, we were able to relocate the Regional meet to the Canada Games pool from our outdoor venue only three weeks prior to the meet date. Without such great clubs, volunteers and administration, these changes would have never have been possible.

We had numerous clubs from both the Kootenays and Lower Mainland regions participate in our Kelowna, Merritt, and Penticton meets. Thanks to all who travelled and special thanks goes out to those officials that volunteered their time in helping us out on deck.

Once again, our region hosted the Coaches Conference. From all accounts it was really well attended and I have received lots of great reviews. Thanks to all who organized and participated at the RockRidge event. Thanks to the BCSSA Board for sponsoring two volunteer coach clinics in our region. Thanks goes out to Penticton and Salmon Arm, for holding the events and the 30 young people who are well on their way to becoming our next group of great BCSSA coaches.

Thanks to Sean, Disa and the rest of the staff and board who make this provincial meet happen.
